

**FRANK'S REDHOT COLLEGE BASKETBALL PROMOTION**  
**Full Official Rules**

## 2. HOW TO ENTER:

or logoed merchandise. *(Note: any Heineken USA brand may be used in the photo.)* Follow the on-screen entry instructions. You must fully complete the registration, including your first and last name, date of birth, street address (no P.O. Boxes except in the state of Washington), city, state, zip code, daytime telephone number (including area code), and e-mail address. **Include the optional name of your server and the location of your photo in the comments.** Normal time rates, if any, charged by Internet service provider will apply. All Internet entries must be submitted by 11:59 p.m. ET on 4/2/18.

By submitting an entry, entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of Sponsor and its appointed agents, which will be final and binding in all matters relating to the Promotion. By submitting an entry, entrants are automatically entered into the Instant Win Program, the Weekly Sweepstakes and the Grand Prize Sweepstakes. **Limit one (1) entry per person per day regardless of method of entry, and each photograph submitted must be unique. Duplicate photographs will be declared void and will be discarded.**

### 3. PHOTOGRAPH GUIDELINES

**All entry information and photographs shall be collectively referred to herein as the "Submissions" or each as a "Submission." By entering, each entrant warrants and represents the following with respect to his/her Submission: that each submitted photograph (a) was taken by entrant and is his/her original work; (b) does not incorporate or include anything that would require the consent of any third party, including persons who have not provided their written consent (which shall be provided to Sponsor upon request thereof) to be photographed and the photograph to be used as permitted herein, (c) does not violate any copyright, trademark, publicity right, privacy right, or any other right of any third party; and (d) does not violate these Official Rules, including the usage guidelines found herein.**

- Copyrighted material owned by any entity other than Sponsor except for Dos Equis (including photographs and other works of art or images).
- Material embodying the names, likenesses, or other indicia identifying any person other than Sponsor and the Frank's RedHot and Dos Equis product images, including, without limitation, celebrities and/or other public or private individuals, living or dead.
- Material containing any personal identification, such as names, street addresses, or e-mail addresses other than those of Sponsor.
- Material identifying any retail licensee, whether selling for consumption on or off the licensed premises.
- Material communicating any messages or images inconsistent with the positive image and/or goodwill Sponsor wishes to project.

#### **4. ELIGIBILITY:**

Open to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older as of date of entry. The following individuals and members of their families (parents, grandparents, children,

siblings, spouses) and immediate households (whether related or not) are not eligible for participation: employees, officers, and directors of Sponsor and its parent, subsidiary, and affiliated companies, alcoholic beverage suppliers, wholesalers, distributors, and importers, alcoholic beverage retailers, and Sponsor's advertising and promotional agencies. All federal, state, and local regulations apply.

## 5. PRIZES:

All Promotion prize details are at Sponsor's sole discretion. The actual make and model of prizes included will be determined by Sponsor in its sole discretion. Prizes to be awarded "as is" and any and all warranties and/or guarantees (if any) shall be subject to the prize manufacturer's terms; therefore, winners agree to look solely to such manufacturer(s) for any such warranty(s) and/or guarantee(s), if any. Any prize depiction is for illustrative purposes only and shall not be relied upon. Prizes are not transferable or redeemable for cash. No substitutions of prizes by winners are allowed, but Sponsor reserves the right to substitute a prize of equal or greater value at its sole discretion.

- (a) **Instant Win Prizes (25):** A total of twenty-five (25) Instant Win prizes will be randomly awarded during the Promotion Period. Each Instant Win prize is a fifty dollar (\$50) gift card towards dining, tickets or team merchandise. Gift card shall be from the Sponsor designated gift card provider, and subject to the terms and conditions of the issuing gift card company. Retail value of all Instant Win prizes: \$1,250.
- (b) **Weekly Sweepstakes Prizes (6):** A total of six (6) Weekly Sweepstakes prizes will be awarded. Each Weekly Sweepstakes prize will consist of a YETI Tundra 45 Cooler. Approximate retail value (ARV) of each weekly prize: \$349.99. ARV of all weekly prizes: \$2,099.94.

Drawings for Weekly Sweepstakes prizes will be held on the following dates: 2/27/18 - 3/6/18 - 3/13/18 - 3/20/18 - 3/27/18 - 4/3/18

- (c) **Grand Prize (1):** One (1) grand prize will be awarded. The grand prize consists of round-trip coach airfare for two to San Antonio, TX from the gateway airport nearest winner's residence departing on 3/30/18 and returning on 4/3/18, four (4) nights hotel accommodations for two (2) people (one room—double occupancy), and a one thousand dollar (\$1,000) StubHub gift card. ARV of grand prize: \$4,000. Actual retail value of prize may be more or less depending on where winner resides.

In the case of the grand prize, exact transportation and accommodation details, dates, times, and terms to be determined at the sole discretion of Sponsor. If winner resides within one hundred (100) miles of San Antonio, TX, Sponsor reserves the right to substitute ground transportation in lieu of air transportation. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel and accommodations are subject to availability. Other restrictions may apply. will be forfeited. Once travel is booked, any penalties incurred as a result of changes to flights are the sole responsibility of winner. Travel is subject to the terms and conditions set forth in these Official Rules and those set forth by Sponsor's airline carrier of choice as detailed in the passenger ticket contract. All expenses and travel costs incurred as a result of seeking or winning a prize are the sole responsibility of grand prize winner. ARV of all prizes: \$7,349.94.

**6. ODDS OF WINNING:**

**(a) Instant Win**

Odds of winning an Instant Win prize are dependent on the number of eligible Instant Win entries divided by the number of prizes available.

**(b) Weekly Sweepstakes**

Odds of winning a Weekly Sweepstakes prize are dependent on the number of eligible entries received prior to each weekly drawing date as set forth in Section 5 above.

**(c) Grand Prize Sweepstakes**

Odds of winning a grand prize are dependent on the number of eligible entries received by 11:59 p.m. ET on 3/18/18.

Entrants are limited to one (1) Instant Win Prize and/or one (1) Weekly Sweepstakes prize per person or household, but are still eligible for a chance to win the Grand Prize provided their entries are submitted prior to the grand prize drawing date of 3/18/18.

**7. WINNER SELECTION, NOTIFICATION, AND VERIFICATION:**

- (a) Instant Win:** Potential Instant Win prize winners will be selected at random and notified shortly after entry is received by Sponsor. If you are a potential Instant Win prize winner, you will receive a message stating that you have won an Instant Win prize.
- (b) Weekly Sweepstakes:** Potential winners in the Weekly Sweepstakes portion of the Promotion will be selected in a series of random drawings from among all eligible entries received prior to the dates set forth in Section 5. Drawings will be conducted by Sponsor or its appointed agent, and all decisions are final.
- (c) Grand Prize Sweepstakes:** The potential grand prize winner will be selected from among all eligible entries received prior to the grand prize drawing date of 3/19/18. Drawing will be conducted by Sponsor or its appointed agent, and all decisions are final.

Potential winners will be contacted by telephone, e-mail, or a post to potential winner's social media account, depending on method of entry. If any potential prize winner cannot be reached within forty-eight (48) hours of first notification attempt, if any prize or prize notification is returned as undeliverable, if any potential prize winner rejects his/her prize, or in the event of noncompliance with these Official Rules, such prize will be forfeited and an alternate winner will be selected from all remaining eligible entries. Upon forfeiture of any prize, no compensation will be given. Limit one (1) prize per person or household, except that the winner of an Instant Win and/or a Weekly prize is still eligible for a chance to win the grand prize, provided his/her entry has been submitted by 11:59 p.m. ET on 3/18/18.

Sponsor reserves the right to alter, suspend, or terminate the Promotion at any time and with or without notice if, in Sponsor's sole discretion, the integrity of the Promotion becomes or is likely to become compromised in any way. In the event the Promotion is terminated prematurely, all eligible entries received prior to the Promotion termination or suspension date will be included in the next prize drawing. All entries become the sole and exclusive property of Sponsor and will not be acknowledged or returned. Delivery of a prize will require a street address located within the fifty (50) United States or the District of Columbia. Sponsor is not responsible for late, incomplete invalid, unintelligible, misdirected, technically corrupted, or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human, or electronic. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

In case of a dispute as to the identity of any Twitter or Instagram entrant, an entry will be declared as made by the authorized Twitter or Instagram account holder used for entry. In case of a dispute as to the identity of any Internet entrant, an entry made by Internet will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry. The "authorized account holder"

is deemed the natural person who is assigned to an e-mail address by an Internet access provider, service provider, or other online organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry.

If for any reason the Promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorized intervention, automated entries, fraud, technical failure, human error, or any other cause beyond the control of Sponsor that corrupts or affects the administration, security, fairness, integrity, or proper conduct of the Promotion, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify, or suspend the Promotion. Sponsor assumes no responsibility for any error, omission, interruption, telephone or other communications malfunctions, deletion, defect, delay in operation or transmission, communications line failure, or theft or destruction of, unauthorized access to, or alteration of entries. Sponsor is not responsible for any problems or technical malfunctions of any telephone networks or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems or traffic congestion on the Internet or at any website, any combination thereof, or otherwise, including any injury or damage to entrant's or any other person's computer related to, or resulting from, participation or downloading of any materials in the Promotion.

Sponsor and its agents are not responsible for printing, distribution, or production errors and may, in their sole discretion, rescind, cancel, suspend, modify, or revoke this Promotion based upon any such error without liability. If by reason of a printing, computer, or other error more prizes are awarded in a prize category than the number set forth in these Official Rules, all persons purportedly making valid claims will be included in a random drawing to award the advertised number of prizes available. In no case will more than the advertised number of prizes be awarded. Antifraud detection devices may be used for verification purposes. **10. DISPUTES AND GOVERNING LAW:**

The parties waive all rights to trial in any action or proceeding instituted in connection with these Official Rules, including, without limitation, the Promotion. Any controversy or claim arising out of, or relating to, these Official Rules and/or the Promotion shall be settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association. Any such controversy or claim shall be arbitrated on an individual basis and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in New York City, New York.
